Set Up: 4 PM SHARP. All vehicles **MUST BE** removed from the street by 4:45 p.m. or be towed. Arrive no later than 4:30 p.m. NO EXCEPTIONS. No early break down. Vehicles will be permitted back on site at 9 pm, and must be off the street by 9:45. NO EXCEPTIONS- if you do not comply, you WILL be asked not to return and loose the fee already paid!!!

CONDITIONS

All Vendors will be located in the center of the street, and will extend 10 feet back toward the curb. The space in between the sidewalk and the back of your booth must be left open and accessible. Vendors are responsible for keeping their displays clean. All trash and boxes are to be taken with you. No refuse to be left on the street or on the curb or in receptacles on the sidewalk. No electric service. Battery operated lanterns are recommended.

Any merchandise deemed by the committee objectionable and not in keeping with our family atmosphere must be removed. Nuisance items such as Silly String, spray paint, toy guns, knives, fireworks of any kind, etc. are prohibited from the event and cannot be sold by Vendors. Any non-compliance with the above stated rules or state and local regulations will result in expulsion from the Event without refund or further recourse. Judgment by the Committee is final.

Insurance required (your OWN or available for a small fee from our Insurance Co) naming Greater Patchogue Chamber of Commerce, Inc. as additionally insured and certificate holder.

REGISTRATION and FEES

Pre-registration by application only. Deadline: April 30, 2010. \$200.00 payment in full for 1 space or a \$100 deposit (balance due June 15th) must accompany your registration application.

Additional space fees: \$250.00 for all 4 nights for one (1) 10 X 10 foot space. We will do our best to accommodate requests for placement, but we are numbering the apps as they come in, and spots will be on a first come, first serve basis. . No Refunds due to inclement weather.
